The owners or operators of port terminal and docking facilities utilizing port rail spurs shall report to the Port Commission on a monthly basis no later than the 5th day of the following month the total number of rail cars either shipped or received by rail. Likewise a similar quarterly report shall be required of the transportation or rail company involved with the actual transport of said cargo. Upon receipt of this report, a rail user tariff fee shall be calculated at the rate of \$15 per rail car per month and an invoice shall be forwarded to the receiver or shipper at the Port of West St. Mary and shall be paid within a 30 day period of the date of the invoice.
